ALABAMA STATE CHIROPRACTIC ASSOCIATION CODE OF ETHICS

Members of the ASCA subscribe to a body of ethical statements developed primarily for the benefit of the patient. The chiropractor must recognize responsibility not only to patients, but also to society, to other health professionals, and to self. The following principles are standards of conduct which define the essentials of honorable, ethical behavior for the chiropractor.

A chiropractor shall be dedicated to the task of providing competent, compassionate health service with respect for the dignity of those served.

A chiropractor shall deal honestly with patients as to the gravity and prognosis of their cases.

A chiropractor shall deal ethically and honestly with all parties concerned with regard to fees charged for services rendered.

A chiropractor shall in the provision of appropriate patient care be free to choose whom to serve, with whom to associate, and the environment in which these services are performed.

A chiropractor shall not hesitate to obtain consultation or use the talents of other health professionals when indicated.

A chiropractor shall treat fellow chiropractors with kindness and every ethical consideration, but shall not hesitate to expose those chiropractors who are deficient in character or who engage in fraudulent or deceptive practices.

A chiropractor shall respect the law but shall in the interest of health freedom seek to change those requirements which are contrary to the best interests of the patient.

A chiropractor shall safeguard patient confidences, providing this can be done within the constraints of the law.

A chiropractor shall continue to improve in knowledge and skill, and shall keep aware of new developments within the profession.

A chiropractor shall recognize a responsibility to the community and to those activities which seek to improve it.

A chiropractor shall welcome the chance to disseminate factual information to the public through any ethical channel. Should this be in the form of personal advertising it shall be in good taste and professional in character.

A chiropractor shall recognize the right of fellow chiropractors and their immediate dependents to gratuitous services. Such services shall be cheerfully and gratuitously afforded.

Should any of the above Code of Ethics not be followed by a member of the ASCA that individual and the circumstances shall be brought before the Ethics Committee of the ASCA and if the committee finds cause, the matter shall be turned over to the ASCA Board of Directors for dispensation.
